



Fresh Views of London 24 Hour Film Competition Participant Agreement

This is an agreement between, _____, representing the film team known as _____, (hereafter known as 'FV Participant') and the **Screening The City**, (hereafter known as 'StC'), with respect to FV Participant's involvement in the **FV of London 24 Hour Film Competition 2008** (hereafter known as '**Competition**') and creation of a short film/video (the "**Film**") pursuant to the terms below.

1. The FV Participant hereby agrees to take part in the Competition, being produced by StC and scheduled to take place on 21st June 2008 [**filming dates extended**]. FV Participant hereby states that he/she has read, and agrees to abide by, the "Official Rules of the Competition," of which are attached hereto and incorporated herein.
2. It is understood that StC reserves the right to screen or exhibit only those films/videos, which adhere to the "Official rules of the Competition." FV Participant hereby understands that he/she is responsible for all crew, cast, equipment, sets, locations, and other items necessary for participating in the Competition, and all costs, expenses, damages and claims related thereto.
3. StC is providing the event and the guidelines in which the FV Participant is taking part; a screening opportunity for all of the completed work; and prize(s) for the winner(s). The FV Participant hereby affirms that he/she will secure all rights to images, sounds and music used in his/her project; and/or will secure talent and location releases where necessary.
4. The FV Participant hereby affirms that he/she will secure a signed Participation Form from any cast and crew and hereby indemnifies, saves and holds harmless StC from any and all claims, costs, damages, expenses and liabilities arising from the creation, use or participation hereunder (including, but not limited to claims for negligence and other torts, unauthorized exhibition, discrimination, fraud, infringement and breach of contract) of FV Participant's film/video.
5. FV Participant hereby acknowledges that StC has the right to screen, show, exhibit, broadcast or disseminate in any way possible, including and not limited to theatrical release, broadcast television, cable television and/or the internet; and the right to publicise StC and Competition using the name or images of and from the "Film."
6. The FV Participant acknowledges that participation in StC 2008 is without remuneration or compensation whatsoever. The consideration for participating in the Competition is the screening of the participant's completed film/video at the conclusion of the competition; and the possibility, although not the obligation of StC, for future screenings; and the opportunity for publicity or exposure for being a participant.
7. The FV participant agrees to immediately provide to StC a signed release for each of his/her participating cast and crew members, using the attached "release" (A). The parties agree that should StC create a compilation, entitled "The Best of the StC 2008," and/or any other subsequent title(s), FV participant will receive a free DVD copy of the compilation.
8. The FV participant agrees that the Competition is for recreational purposes only and that there is no obligation on the part of Screening The City et al to assign a winner or to screen your film if it is not suitable for screening. These and all the rules are at the sole discretion of Screening The City et al.

If any member of the FV Participant team is under 18, a separate copy of this agreement signed by a parent or guardian must be submitted with the completed film.

1) my appearance in the motion picture, still photographs of me, recordings of my voice taken or made of me by it, any music sung or played by me, and my actual or fictitious name; and/or

2) the song or music, known as _____ performed by _____, for which I have the authority to grant**.

**Use of song or music by the Team Producer and/or the FV 24 Hour Film Competition, is strictly limited to the film/video referenced herein.

Furthermore, I acknowledge that the FV 24 Hour Film Competition, or its designates may shoot behind the scenes "making of FV 24 Hour Film Competition" footage, for use in a motion, and I hereby irrevocably grant to FV 24 Hour Film Competition, its licensees, agents, successors and assigns, the right, but not the obligation, in perpetuity throughout the world and in all media, now or hereafter known, to use (in any manner it deems appropriate, and without limitation) in and in connection with the motion picture, by whatever means exhibited, advertised or exploited: my appearance in the motion picture, still photographs of me, recordings of my voice taken or made of me by it, any music sung or played by me, and my actual or fictitious name.

LIMITED LIABILITY: Furthermore, I understand that during my participation in the FV 24 Hour Film Competition, I may be exposed to a variety of hazards and risks, foreseen and unforeseen, that may include, but are not limited to, personal injury, property damage and death. To the fullest extent allowed by law, I agree to waive, discharge claims and release from liability the FV 24 Hour Film Competition, its officers, directors, employees, agents, sponsors, and leaders from any and all liability on account of, or in any way resulting from Injuries or Damages. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any minors accompanying me on the Challenge.
